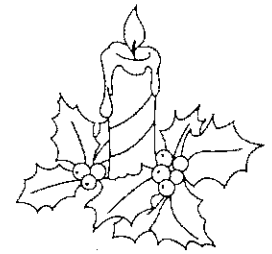

PARADE ENTRY

Every entry must have a minimum of 100 lights. Children's electric and pedal vehicles shall have a minimum of 30 lights. **All parade entries must be staged by 5:15 p.m.** Parade will start at 6:00 p.m. sharp and should finish by 6:54 p.m. Please be early!

Staging Area

Tractor transport trailers and pull-trucks shall not be parked on A Street between Yosemite Avenue and 9th Street to the south. This is the parade staging area and it must be kept clear for staging. Enter the staging area via 9th Street. All parade participants must stage next to curbs and no other vehicles shall park in the staging area. Parade event staff will help with staging and participants must follow their directions. Maintain forward motion at all times. No stopping for more than one minute. Maintain approximately 75 feet between entries. **NO THROWING OF CANDY OR OBJECTS TO THE CROWD.** Small children tend to run into the street to retrieve candy. Those driving the vehicles may not be able to see them. Please respect this very important rule for everyone's safety. **Staging information will be mailed or hand delivered on Monday November 26th.**
